PHYLLIS GARRY

Phyllis began her Boxing officiating career, in 1980 with the Amateur's, in Florida's USA-ABF, as well as the Golden Gloves, and PAL. She began as a record keeping clerk, then gloving table, time-keeper, then eventually studied and tested for the Judging qualification.

She worked the Amateurs, from 1980 - 2000. Officiating both the State of Florida Championships, as well as Regional's... and the GG's State titles... and National's for PAL, at Disney's Sports complex.

She was an USA-Boxing official for the 1996 Olympic Games, in Atlanta, GA. And closing out her Amateur career, with the 2000 Olympic Trials, and the Olympic Box-Off's.

Along the way, she additionally turned Pro, as a Judge, in Pro's from 1987, to 1992... when she began assuming the Time-Keeper's role until currently, in 2017. Which is a 24 year Pro-Career. During her Pro-Judging career, she had 9 World Title Bouts, and traveled to Italy, for the Luigi Castiglioni vs Jose Lagos, WBU bantamweight World title. Additionally, she Judged in MACOU, China, in 1994 doing three Title matches. Her many travels, have taken her to China, Europe, Cayman Islands, USA, Bahamas, working for the many sanctioning bodies such as the WBC, WBA, IBF, WBO, NBA, WBU.

Phyllis has performed Time-Keeping and Bell Ringing, Whistle Blowing task, on HBO, NBC, SHOW-TIME, ESPN, ESPN2, TELMUNDO, UNIVISION, SUNSHINE, STAR in Europe, networks.

Some of her notable World Title's matches included such Champions as: Roy Jones Jr., Antonio Tarver, Winky Wright, David Santos, Lamar Murphy, Francios Botha, Kosta Tzyu, Glenn Johnson, Mike McCallum, Oliver McCall, Henry Akiwandi, Ray Mercer, Shannon Briggs, Hector Camacho and his son Israel Camacho, Christy Martin, Jenna Shiver, Naomi Basques, Steve Forbes, Freeman Barr, Dave Jacob, and his twin sons, Adam & Aaron, Antonio Tarver Jr. Glenn Kelly, Jeff Lacey, Willfredo Vasquez Jr., Davey Armstrong, Pete Fresina, Sir Charles Whitaker, just to name a few... in passing.

A graduate of Hagerstown HS, Hagerstown, Indiana... and Spfld. College, Springfield, Ohio... she has been awarded the Life Time Girl Scout Leader award, along with Saint Elizabeth Ann Seton Award, and Saint Anne Award.... as well, she was a WSI (Water Safety Instructor), for 35 years. She retired from MetLife after 22 years.

She and her spouse, Brian celebrated their 50 th Golden Wedding Anniversary, this past May 28, 2016. Together they still travel the 'Sweet Science' trail, applying their Ringside skills of Time-Keeping, and Judging.
Her business card reads: "I'LL RING YOUR BELL, and STOP YOUR CLOCK"....



And the Adventure Continues...

"And the adventure continues" well sums up our kayak trip to the Weedon Island Preserve according to Sherry Duffy. This trip sure didn't go as advertised. But it ended up as a net positive by the end of the day. Only half of the expected participants showed up so we suspect the other half may have ESP. Apparently Ed bought a house, or sold the farm. I don't really recall. Joan's leg hurt or so we were told. I'm sure the Commodore of Vice had something to do with that, too. So many bailed out I don't even remember who they all were. Those who did show up (there were seven of us) headed over to the Weedon Island Preserve and arrived about 9am. It wasn't long before we learned that Sweetwater Kayak wasn't launching any kayaks due to heavy wind gusts. The recent drought combined with the wind will factor into a later experience.



Instead of calling it a day, we decided to kayak the Hillsborough River from Sergeant Park in the Lower Hillsborough River Wilderness Preserve north of US 301. I'm gonna' guess it was Linda Brandt's idea as she's wise and used to live over that way before. Our four cars arrived at Canoe Escape between 11 and 11:30 and by noon we were on the water. We were treated very well by the staff and, in particular, a very enthusiastic and knowledgeable young man named Mike Cole.

Some of us couldn't wait to eat (ahem...Linda) and ate lunch before we even launched. Linda and I were in the first tandem followed by Ron Poirson flyin' solo in a single kayak. Mike and Sherry Duffy were next in their nifty sectional kayak with Barry Fox and Ellen Henderson bringing up the rear in another tandem.



I didn't realize how much I didn't know or remember. Like for instance what the difference is between a canoe and a kayak, or a paddle and an oar. These things don't occur to me until I'm on the water. For those inexperienced like me a kayak is the one where the paddler is seated with their legs pretty much flat in front of them and use a double-bladed paddle. In the canoe the paddler kneels and uses a single blade. Oars are attached to the rowboat and power in the opposite direction as the rower is facing. The paddles and oars used in kayaks and canoes are not attached and propel in the same direction as the paddler faces.

Being surrounded by Old Tampa Bay and the Gulf of Mexico made it difficult to imagine the drought's effect on the Hillsborough until this outing. On this day, the river was at least a foot below its normal depth and made maneuvering much more challenging. Despite the conditions, the scenery was nevertheless amazing. In fact, because the water level was so low, it afforded us the opportunity to see the great root structures of mighty oaks and cypress trees. It also made it very easy to run aground and grab a bite to eat and chat. It turns out Barry's



family lives a couple hours north of Pittsburgh not far from where I went camping several times as a boy. And Ron Poirson is from Cleveland but that's another story.



Several gators obliged us with their presence on the banks of the river. If I had more time to gawk, I might have gotten scared but the low water depth prevented us from lingering. With Linda pulling double duty at the bow and snapping pictures, I was left with little time to make quick decisions on which exposed rocks or branches we should crash into. But by far the last animals I expected to see were a couple of large, wild boars.



As we approached civilization we could hear what we thought were motorcycles and smelled what many of us thought was a campfire. That turned out to be fool's gold, however. Just before 3pm Linda and I arrived at our endpoint in the Morris Bridge Park missing the 2:30 bus back to Sergeant Park. A Tampa cop was waiting for us because he was evacuating the park. The "campfire" was actually a brush fire blazing to our north at the Flatwoods Wilderness Park. Ron arrived shortly thereafter but chose a so-called "wet exit." I would've thought he'd be perfectly comfortable on a river surrounded by fire (see footnote below) and smoke being from Cleveland and all. Mike and Sherry followed Ron and I've got to give those two credit. I wasn't sure their kayak was going to make it in the water but it did. There were some technical difficulties before we



launched. No big deal, just the malfunction of a piece that held the sections together. Not to be outdone by that was realizing that the "motorcycle engines" we heard earlier in this adventure were in fact alligators courting each other during their mating season which in this neck of the woods is mid April-May. We would later learn that I-75 was closed down and northbound traffic detoured onto the single lane Highway 301. Because of all the traffic the 3:30 bus was delayed a bit. Heading back to Canoe Escape we passed no less than two serious-looking automobile accidents on 301. I believe we were able to depart about 4:30 or so.

I'm grateful to Mike Duffy for giving me a Bugables repellent wristband. Since I've worn these I've not been bitten. I highly recommend one if you don't like bug spray. And last but not least, I'm always happy where I chose to live whenever I return from a trip to the other side of the pond.

THE "MOONLIGHT" RACE - WED.5/10/17

All of the skippers started to pile their crews onto their sailboats around 6:30 pm. **Co-Race Chair, Chris D.** had opted to sail on **Chris Garrill's "John Marie"**, along with **Lisa Lanza, Mike** and **Sherry Duffy**. Aboard **Dale C.'s "Incentive"** we had our Club "Ringer" **Paul M.** plus **Club Photog, Linda B., Emily Wagner** and **Ellen H.**

"Wanderlust", had their usual suspects: Co-owners: **Ron P, Roof D.,** and crew: **Clarence N. "Jewel Anne"**, with owner **Jack M.** and crew **Ed M., Jay Basinger** and **Neil Lieberman** were on board.



Chris Garrill's "John Marie" (along with **Dale C.** as helper) had gone out earlier to light up the South White Mark, as this was **THE "MOONLIGHT" RACE.**

Co-Race Chair, Chris D. set the course for the fleet to head East toward the Orange Mark, then on to the South White Mark, then Finish. **"Incentive"** with her large crew, did the race count down, while jockeying for the first position over the start line. We did a bear-away around the E. pin end then we were off to the races. It was **"Incentive's"** kind of wind.



For most of the race **"Incentive"** was in first place and finished first under a glorious Full Moon. **"Incentive"** hosted another fun Post-Race Party.

THE RACE OF THE "DIRTY BOTTOM BOAT" - WED. 4/12/17

Paul, a very experienced Lake Michigan racer and potential new SHBC member arrived at the Club's Bulletin Board with a 12-pack of beer for the **WED. 4/12** race. In short order **Ron P.** scarfed him up to crew on his boat, **"Wanderlust"**, before **Dale C.** could entice **Paul** over to **"Incentive"** with rum and wine.

After all of the skippers chose their respective crews, five boatloads motored out to the start line. Co-Race Chair **John V.** aboard his **"Pegasus"** instructed the fleet, that since there was a S-S/W wind, the course would be South to the White Mark, then NE to the Orange Mark, followed by the finish, all with port roundings. We (**John V., Jim King** and **Ellen H.**) on **"Pegasus"**, after dropping the S-F marks decided we had plenty of time to practice different starting line approaches. Since it was a fairly strong outgoing tide (from +2....to -0.37), starting on port tack at the East favored pin didn't work, as the tide and changing wind (toward our nose) kept pushing us

away from the line. So even though a starboard approach was favored (also for safety rules within the fleet), it was a slow downwind slog to the line. We also practiced a quick hardening up after the start to head directly toward the white mark. This pre-race practice maneuvering gave **"Pegasus"** a real advantage by being first over the line at 6:05:00 pm, followed shortly by **Barry F's "Amelia"**, with crew **Sherrie Rutland** and **Christy Edwards**, (who with her husband **Tom Potter**) had just returned from Cuba to share their adventures.

Next over the line was **"Wanderlust"** with co-owner/skipper **Ron P.** plus the aforementioned ringer, **Paul** and **Mike Duffy**. They were followed by **Dale C's "Incentive"** with our SHBC Club Photog. **Linda Brandt**, who was the guest skipper.

Since **"Jewel Anne"**, with owner **Jack M.** and crew **Clarence N.** were on the "course side" at the start gun, they were also last to begin the race, once they got on the correct side to start.

"Wanderlust" (with her cleaner bottom) quickly overtook **"Amelia"**, who owed her time with their close ratings (267 vs. 255). So **"Amelia"** opted to drop below the rum line, presumably for increased speed, thus threatening our position on **"Pegasus"**. However, it seemed **"Amelia"** started to slow down, as perhaps she may have been too far off the wind (or because of her dirty bottom). By now **"Wanderlust"** started her move to overtake **"Pegasus"** to windward. We were sweating bullets even though they owed us on corrected time (267 vs. 280). For some reason **"Wanderlust"** also dropped below the rum line and us. We surmised they were gunning for room at the mark if they had caught up. But we on **"Pegasus"** were able to get there first with 2 min. 9 sec. to spare.

Since the 2nd leg was mostly downwind, with some wind correction to a very broad port reach, **"Pegasus"** quickly set her whisker pole as did the remaining fleet. By now **"Wanderlust"** "was again gaining speed on us and by the second (orange) mark rounding they were only 56 sec. behind **"Pegasus"**.

With their cleaner bottoms both **"Jewel Anne"** and **"Incentive"** passed **"Amelia"** on the downwind leg. Even though **"Jewel Anne"** remained ahead throughout the rest of the race, **Barry** got serious (and made a mental note to clean his boat bottom ASAP) and **"Amelia"** was able to pull ahead of **"Incentive"** (to whom they owed 48 sec. per mi.) on the 3rd (windward) leg.

"Pegasus" hardened up for speed only; then we bore away down toward the finish marks. Meanwhile, we had another hour of sunlight, so **John V.** polled the fleet via VHF radio and it was a unanimous vote to extend the course by adding 2 more legs to the White Mark then on to the finish.

Since the outgoing tide was now at its strongest, we on **"Pegasus"** kept having to "yaw" high of the South mark on the 4th leg, in order to make it around the mark. **"Wanderlust"** "was a little off on their calculation and had to tack away, thus missing hitting the mark before rounding it. They were now back to being 2 min. behind **"Pegasus"**.

"Jewel Anne" (perhaps because of her clean bottom) finished 3rd after **"Wanderlust's"** 2nd and **"Pegasus's"** first place. **"Amelia"** was 4th over the finish line followed by **"Incentive"**, who graciously hosted the post-race party with the aforementioned **Paul's** 12-pack of beer and white wine from **Dale's** larder and **Ellen's** snacks. Come out and race with us and enjoy the fun for more glorious weather before the summer rains.
